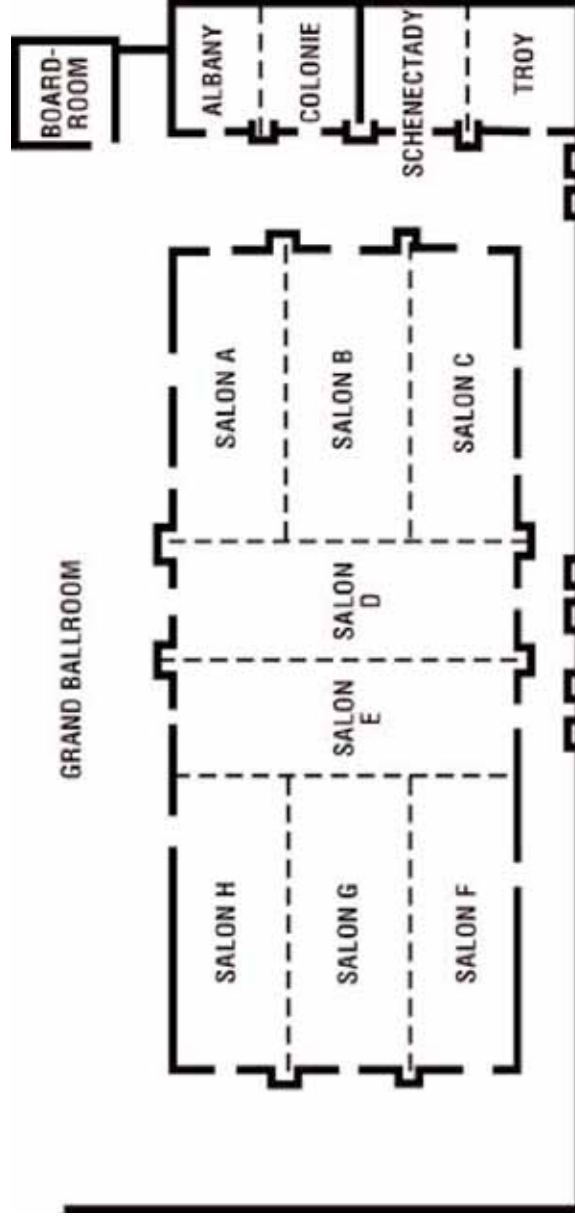
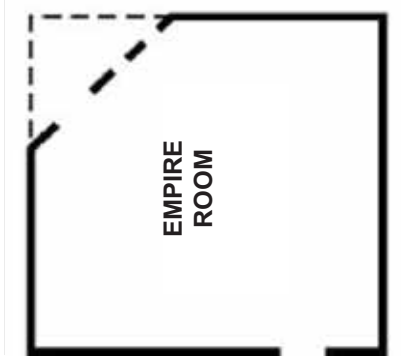

The Hague Convention on International Recovery of Child Support and UIFSA 2008 Approved for 1.5 CLEs

With the U.S. Senate ratification of the Hague Convention on International Recovery of Child Support, the Support Collection Units (SCUs) will be able to take advantage of the new process for establishing and enforcing child support orders among the ratifying nations. SCUs will also be receiving requests for assistance from member nations. In order to implement the Convention, Congress will soon require all states to adopt UIFSA 2008. 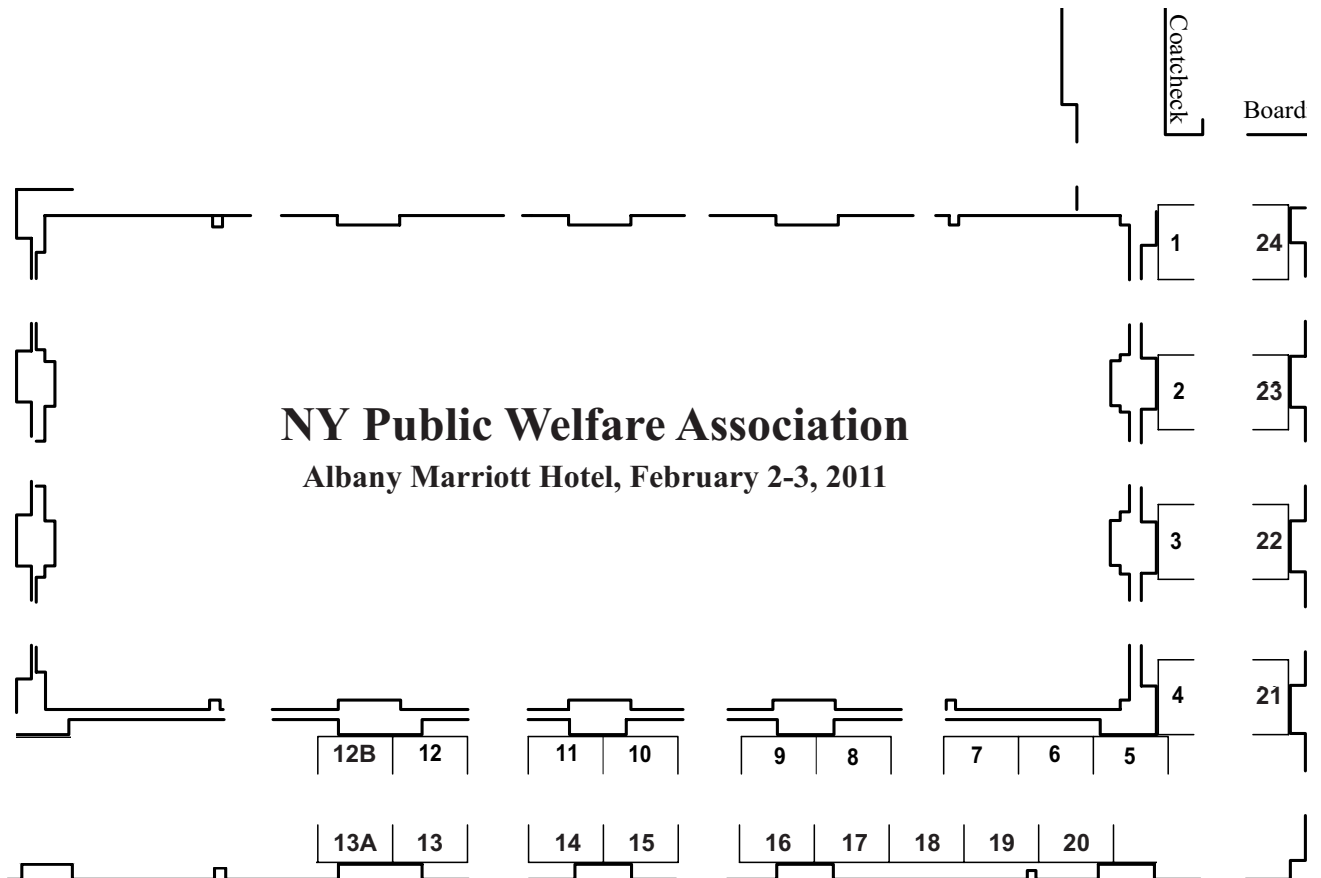

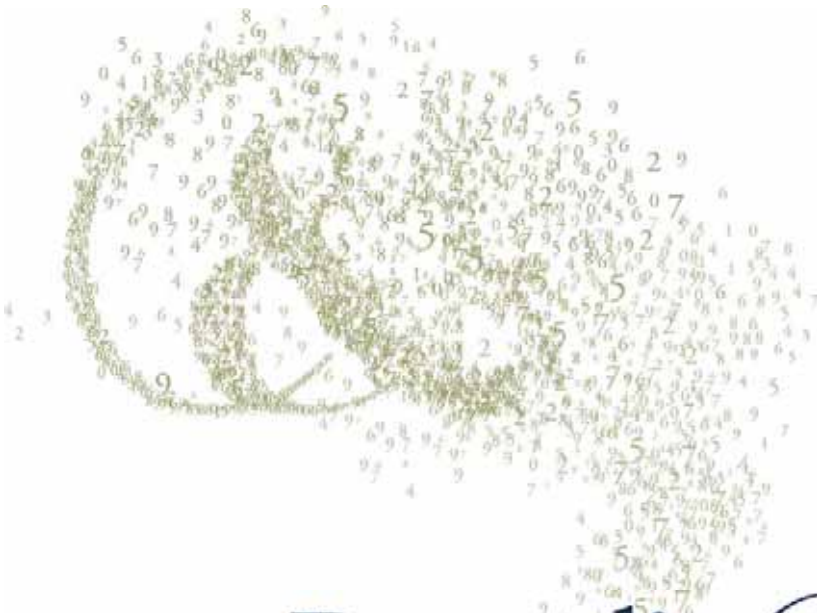
